Hence fresh applications for the Executive Staff of the Department for General Transfer for the year 2012, as per the norms prescribed in the Government Order 1st cited as modified vide the Government Order 3rd cited are invited from the Executive staff of the Department in the proforma prescribed vide the reference 2nd cited, so as to reach this office on or before 25/06/2012. Applications received after the last date prescribed for the receipt of the same and the applications already furnished in this regard will not be considered. Applications for each category shall be forwarded in separate lots.

The Heads of Officers are directed to collect and countersign the applications for transfer from the Executive Staff after necessary verification, with reference to their service records within the stipulated time limit, i.e, before 25/06/2012. The applications thus furnished will be valid only for the General Transfer 2012.

The Heads of Offices are also instructed to bring the contents of this circular to the notice of all executive members by internal circulation and display on Office board prominently.



Abstract

Transport Department - Motor Vehicle Department- Norms for the transfer and posting of employees in Motor Vehicle Department - modified - Orders issued.

ORDER

As per Government Order read above Government issued guidelines/norms for the transfer and posting of employees in the Motor Vehicles Department. In this Government order in para 19, it was ordered that the executive employees, who have not completed 3 years of service in a station would not be transferred. However officers found unsuitable might be shifted in the public interest.

Considering the special nature of work of executive staff of Motor Vehicles Department, Government find that the period of 3 year in a station is too long. Hence Government have reviewed the transfer norms and the following modifications are ordered under the heading "Executive Statt" in para 19 viz:

the existing clause shall be substituted by the following.

The period of service of Regional Transport Officer and Joint Regional Transport Officer in a station will be limited to one year and the period of service of AMVI and MVI in a station will be limited to 2 years. However officers found unsuitable may be shifted in the public interest. All those who complete five years in a single or various posts in one district should be transferred to other districts. The Transport Commissioner may shift the officers posted in check posts once in three months based on the appraisal of performance of such officers.
