Sub: Request for seizure of CARS imported by foreign nationals  
under CARNET SCHEME REG.

It is to inform that the motor vehicle as per description mentioned in attached list were imported by foreign nationals for touring purpose in India under 'CARNET SCHEME'. In terms of said scheme the tourist can keep the vehicle in India for a period of six months from the date of importation & thereafter they have to export said vehicle unless extension in time period is granted by the 'COMMISSIONER OF CUSTOMS'.

However, the vehicles as mentioned in attached list have not been exported even after expiry of validity period. Non-exportation of said vehicle attract not only the levy of customs duty but also confiscation there of & imposition of fine and penalty.

Since the whereabouts/location of these vehicle is not known and possibilities of plying some of the vehicle in the State of Maharashtra, can not be ruled out, it is requested to instruct the executive staff under your charge to keep a vigil on the listed motor vehicle and if found plying, the same may be detained and handover to the nearest police station along with the person in possession of the vehicle and the matter kindly be reported to the OFFICE OF THE COMMISSIONER (EXPORT), Jawaharlal Nehru Custom House, Nhava Sheva, NAVI MUMBAI

In case, the motor vehicles as listed in annexure are brought to you with the request for transfer of ownership, such request may not be considered unless clearance from duty angle and adjudication point of view is granted by the Customs.
