**Order No. C2/23595/TC/2009 dated 24.12.2009**

(1) As per the 1<sup>st</sup> paper read above, the Regional Transport Officers were directed to organize Road Safety Programmes utilizing the funds allotted under the Annual Plan 2009-2010 limiting the expenses to Rs. 15000/- per Regional Transport Officer, with direction to conduct the programmes before 30.09.2009 and to furnish the detailed statement of expenditure on or before 31.10.2009.

(2) In connection with the Road Safety Week from 01.12.2009 an amount of Rs.15000/- per Regional Transport Officer was also allotted as per the letter read as 2<sup>nd</sup> paper above, with direction to furnish the report of the activities and expenditure statement before 15.12.2009.

(3) The 21<sup>st</sup> National Road Safety Week is to be observed from the 1<sup>st</sup> of January 2010, for which an amount of Rs. 15000/- is being allotted to each Regional Transport Officer.

Accordingly Rs. 30000/- each is sanctioned to the following Regional Transport Officers as detailed below for incurring the expenses in connection with the above 2 programmes.
