Sub: Motor Vehicles Department — Enforcement — Directions issued -
regarding.

Ref: Earlier Directions in the matter

The Government of Kerala has constituted 17 new Mobile Enforcement Squads so as to form an Enforcement Wing consisting of 34 Mobile Enforcement Squads. The performance of the Mobile Enforcement Squads including the revenue collection generated is evaluated by the Government from time to time. Hence the performance of the Mobile Enforcement Squads shall not be decelerated by deputing the officers for other duties.

All Regional Transport Officers (Enforcement) are directed to issue a checking programme to the Mobile Enforcement Squads under them with time slot. A copy of the programme shall be forwarded to the undersigned for super checking the Mobile Enforcement Squads at the place of check, at the time furnished in the checking programme. Instead of checking at a particular spot the Mobile Enforcement Squads shall concentrate on offences during movement such as using mobile phone while driving, driving through wrong side, violating lane discipline, red light jumping, parking on one way road or driving in wrong direction etc.

The Regional Transport Officer shall prepare the checking programme showing the offences to be concentrated each week such as,

- (i) **Stage Carriage offences:-** Reserved seats for ladies, senior citizens and handicapped not given to them, crew are not wearing the uniform and name plate as prescribed, destination boards not displayed properly, using audio system and prohibited horns, offences regarding lights etc.
- (ii) **Check for helmet and seat belt** for driver and front seat passenger, rear view mirrors not provided, saree guard not fitted, registration number not properly exhibited, lights of prohibited colour and intensity used etc.
- (iii) **Check for Tax, CF and Permit:-** Check at Autorikshaw Stand, Contract Carriage Stand, at remote places such as granite quarries, river sand beds, godowns etc.
- (iv) **Check for illicit operations:-** Check illicit taxis, rent a car, parallel Stage Carriage operation, Stage Carriage conducting Contract Carriage operation with out special permit etc.
- (v) **Parking violations:-** Parking on road, wrong side, on foot path, near junctions and busy roads etc.


The report of checking showing the number of check reports prepared by each Mobile Enforcement Squads, offences detected and compounding fees collected shall reach the undersigned within 2 days after the completion of each month. The Mobile Enforcement Squads team shall be properly instructed to avoid complaints of bribe and harassments.
