Sub:- Motor Vehicles Department - Road safety Measures - Action against over speeding of drivers and other offences - imposing of penalty orders issued - reg.

Ref:- This office Circular No.06/2008 dated 08.03,2008

The licensing Authorities of the State were directed vide circular referred above to invoke the provisions of Section 19 (1) of the MV Act against over speeding drivers. On review it is seen that some clarifications are required in the above referred circular. Hence this is issued in modification of the referred circular.

All officers are instructed to initiate action in accordance of the provisions of law as detailed below to discourage wrong driving practices and to enhance road safety.

Sl.Nos. 1 to 4 talk about cases where the police have charge sheeted the cases. This would include accidents which have happened in the past for which charge sheets are being filed now after investigation. However, whenever sensational accidents involving deaths or serious injuries occur, it will be the duty of the Regional Transport Officer/JT. Regional Transport Officer concerned to ensure that an officer is deputed to verify the details and whenever negligence by driver is 'prima facie' revealed the Regional Transport Officer/Jt. Regional Transport Officer shall initiate action for suspension/revocation of driving licence of the Driver/Drivers concerned according to

the gravity of the incident without waiting for filing of charges sheet observing all formalities prescribed in MV Act/Rules.

The requisition letter of the Police Officer for the inspection of the vehicles involved in the accidents shall be taken as intimation by the Police in the above cases. The M.V.Dept: officer who conducts such inspection shall file a report to the RTO/JRTO giving necessary details for initiating action as above.

As per sub section 20 of Section 2 of MV Act 1988, Licensing Authority means an authority empowered to issue licenses under chapter II& III of the MV Act. Hence Licensing Authorities and Additional Licensing Authorities are empowered to exercise any powers vested with the licensing authority, including the power to disqualify a person from holding the driving license or to revoke it.

All Officers are directed to give adequate publicity to the action taken as above which will strengthen the road discipline among drivers. All Deputy Transport Commissioners, Regional Transport Officers and Joint Regional Transport Officers are hereby directed to forward a monthly report stating the details of action taken under section 19 (1) (f) with all particulars based in this Circulars on or before 10th of succeeding month in the name cover of Assistant Transport Commissioner.
