S. R. O. No. 235/2011.—In exercise of the powers conferred by clauses (r) and (uu) of rule 2 of the Kerala Motor Vehicles Rules, 1989, and in supersession of all the existing notifications on the jurisdiction of Kollam and Pathanamthitta regions, the Government of Kerala hereby notify the area comprising the regions and the sub-regions thereunder in the revenue districts of Kollam and Pathanamthitta as follows, namely:—

I. Kollam Region

The Karunagappally Taluk, Kunnathur Taluk, Kollam Taluk, Kottarakkara Taluk and Pathanapuram Taluk.

- (a) Karunagappally sub-region
The Karunagappally Taluk.
- (b) Kottarakkara sub-region
The Kottarakkara Taluk.
- (c) Punalur sub-region
The Pathanapuram Taluk.
- (d) Kunnathur sub-region
The Kunnathur Taluk.

II. Pathanamthitta-Region

The Adoor Taluk, Kozhenchery Taluk, Mallappally Taluk, Ranni Taluk and Thiruvalla Taluk.

- (a) Adoor sub-region
The Adoor Taluk.
- (b) Mallappally sub-region
The Mallappally Taluk.
- (c) Ranni sub-region
The Ranni Taluk.
- (d) Thiruvalla sub-region
The Thiruvalla Taluk.

Explanatory Note


(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O. (Ms.) No. 83/2010/Tran. dated 13-12-2010 Government of Kerala have inter alia sanctioned new Sub-Regional Transport Offices at Kunnathur and Ranni. Therefore, Government have decided to define the local area of jurisdiction of Sub Regional Transport Office Kunnathur under the Regional Transport Office, Kollam and the Sub-Regional Transport Office Ranni under the Regional Transport Office Pathanamthitta.
