S.O. 2610(E).—In exercise of the powers conferred by Sub-section (3) of Section 109 of the Motor Vehicles Act, 1988 (59 of 1988), the Central Government hereby notifies the Automotive Industry Standards for various parts, components and assemblies used in the manufacture of motor vehicles as specified in the following table, namely :—
