As per the order read 1 above, it has been directed to take necessary action for selling all the unclaimed confiscated sand vehicles, lying in the premises of various police stations and revenue offices in the district by e-auction through M/s MSTC Ltd. company. Subsequently, as per the order read 2 above, the district collector, Kozhikode has delegated the power to the Revenue Divisional Officer/Sub Divisional Magistrate to take all the necessary steps to clear all such vehicles through e-auction and made the Revenue Divisional Officer/Sub Divisional Magistrate as nodal officer for e-auction and convener of the Fare Value Fixation Committee, led by the executive engineer, PWD (Mechanical) Division, Kozhikode.

As per the letter read 3 above, the Asst. Executive Engineer, PWD (Mechanical) Division, Kozhikode has submitted a report, showing valuation of vehicles stranded at Atholi, Koduvalli, Mavoor, Koorachundu police stations and civil station premises. Vehicles have been made into LOTS as per its location and put for e-auction on 12.4.2017. M/s J K Iron Steels, 189/10, 11, Diara Street, Palakkad, PIN - 678001 has taken the auctions of LOT 1 (Atholi Police Station), LOT 2 (Civil Station), LOT 3 (Koduvally Police Station) and LOT 4 (Koorachundu Police Station) for Rs. 38,767/-, Rs. 3,10,400/-, Rs. 4,11,001/- and Rs. 2,40,001/- respectively. M/s Maamu Motors, 420, Near LIC Office, Sirimugai Road, Mettupalayam, Coimbatore, PIN - 641301 has taken the auction of LOT 5 (Mavoor Police Station) for Rs. 25,21,019/-. Details of the e-auction are given as Annexure 1 of this order. The firms have remitted the respective auction amounts in the District Collector's River.

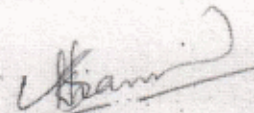
Management Fund and as per the letter read 6 above, the district collector has acknowledged the receipt. However, out of 50 number of vehicles of LOT 5 (Mavoor Police Station), one vehicle bearing registration number KL-11-Z-4606, whose proceedings are undergoing in this office, is inadvertently included in the auction list. Since the firm has requested to release rest of the vehicles forthwith, the case of vehicle No. KL-11-Z-4606 will be decided upon completion of the ongoing proceedings in this regard.

In these circumstances, it is hereby ordered to release the vehicles as described in the Annexure I of this order without send to the representatives of M/s J K Iron Steels, 189/10, 11, Diara Street, Palakkad, PIN - 678001 and M/s Maamu Motors, 420, Near LIC Office, Sirimugai Road, Mettuppalayam, Coimbatore, PIN - 641301. The above mentioned firms are required to remove completely all the vehicles taken on auction as per the Annexure I from the respective premises before 15.6.17. Otherwise, demurrage charges as per the rule will be levied on the firms or the auction amount remitted will be confiscated and the vehicles will be re-auctioned.

The responsible officers are required to release the vehicles to the representatives of the above said firms after verifying their identity cards issued by M/s MSTC Ltd. company and also to provide all the necessary support to remove all such vehicles from their respective premises. Since all these vehicles are auctioned as scrap, the respective Regional Transport Officers/Joint Regional Transport Officers are directed to cancel the registration of all the auctioned vehicles mentioned in the Annexure I of this order and cease all the cases related to these vehicles, if any.
