**NOTIFICATION**

G.O.(P) No.40/2013/Tran.     Dated, Thiruvananthapuram, 2<sup>nd</sup> May, 2013.

S.R.O.No.-----/2013.- In exercise of the powers conferred by clauses (r) and (uu) of rule 2 of the Kerala Motor Vehicles Rules, 1989 and in modification of the existing notification in respect of the areas of jurisdiction of Regional Transport Office, Alappuzha and Sub-Regional Transport Offices at Cherthala, Chengannur, Kayamkulam and Mavelikkara, the Government of Kerala hereby notify the area of Sub-Regional Transport Office, Kuttanad and redefine the areas of Regional Transport Office, Alappuzha and Sub - Regional Transport Offices at Cherthala, Chengannur, Kayamkulam and Mavelikkara as follows, namely:-

- (1) The Regional Transport Office, Alappuzha shall have jurisdiction over Ambalappuzha Taluk, Cherthala Taluk, Chengannur Taluk, Karthikappally Taluk, Kuttanadu Taluk and Mavelikkara Taluk.
- (2) The Sub Regional Transport Office, Cherthala shall have jurisdiction over the following villages in Cherthala Taluk, namely:-

- (i) Arukutti
- (ii) Aroor
- (iii) Cherthala Vadakku
- (iv) Ezhupunna
- (v) Kadakkarappally
- (vi) Kodamthuruthu
- (vii) Kuthiyathodu
- (viii) Pallippuram
- (ix) Panavally
- (x) Pattanakkad
- (xi) Perumbalam
- (xii) Thanneermukkam Vadakku
- (xiii) Thuravoor Thekku
- (xiv) Thaikkattusseri
- (xv) Vayalar East

- (3) The Sub Regional Transport Office Chengannur shall have jurisdiction over Chengannur Taluk.
- (4) The Sub - Regiononal Transport Office Kayamkulam shall have jurisdiction over Karthikappally Taluk.
- (5) The Sub - Regional Transport Office Mavelikkara shall have jurisdiction over Mavelikkara Taluk.
- (6) The Sub - Regional Transport Office Kuttanadu shall have jurisdiction over Kuttanadu Taluk.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport)

As per G.O.(Ms) No.61/2012/Trans dated 09/10/2012, Government of Kerala have sanctioned eight new Sub-Regional Transport Offices including Kuttanadu. Therefore, Government have decided to bifurcate and redefine areas of Regional Transport Office, Alappuzha, Sub - Regional Transport Office, Cherthala, Sub - Regional Transport Office, Chengannur, Sub Regional Transport Office, Kayamkulam and Sub - Regional Transport Office, Mavelikkara and define the area comprising Sub - Regional Transport Office, Kuttanad with in the Alappuzha Region.
