In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Transport



Subordinate Service Rules, 2008 issued under G.O. (P) No. 16/2008/Tran. dated 7th April, 2008 and published as S.R.O.No. 370/2008 in the Kerala Gazette Extraordinary No. 726 dated 8th April, 2008, namely:-

RULES

1 . *Short title and commencement.*- (1) These rules may be called the Kerala Transport Subordinate Service (Amendment) Rules, 2022.

(2) They shall come into force at once.

2. *Amendment of the Rules*. - In the Special Rules for the Kerala Transport Subordinate Service Rules, 2008,-

(1) in the TABLE under rule 5,-

(i) in column (2), against the entry "1. By direct recruitment" in column (1),-

(a) for the entry in sub-item (i) of item 2, the following entry shall be substituted, namely:-

"2(i) A Diploma in Automobile Engineering or Mechanical Engineering (3 year Course) awarded by the State Board of Technical Education or any institution recognised by the Central Government or State Government or";

(b) entries against item 3 shall be omitted.

(ii) in column (2), against the entry "2. By transfer" in column (1),-

(a) for the entry in sub-item (i) of item 2, the following entry shall be substituted, namely:-



"2(i) A Diploma in Automobile Engineering or Mechanical Engineering (3 year Course) awarded by the State Board of Technical Education or any institution recognised by the Central Government or State Government or";

(b) entries against item 3 shall be omitted.

(2) after rule 10, the following rules shall be inserted, namely:-

"11. *Training*:- A probationer in the service shall undergo training for a period of ten months as per the schedule notified by the Transport Commissioner.

12. *Savings*:- Notwithstanding anything contained in rule 11, the training specified therein shall not be applicable in the case of persons who entered the service prior to the date of publication of these rules.".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government of India, as per notification, S.O.443(E) dated 12th June, 1989 published in the Gazette of India Extraordinary Part II, Section 3(ii) dated 12th June, 1989 as amended by notification No.S.O.1215(E) dated 8th March, 2019, have amended the minimum qualification prescribed for officers of the Motor Vehicles Department. The Government have decided to amend the Special Rules in respect of the qualification of Assistant Motor Vehicle Inspectors of the Motor Vehicles Department in the State, in accordance with the revised minimum



qualification fixed by the Central Government and introduce ten months training to the probationer. Hence, the Special Rules for the Kerala Transport Subordinate Service, 2008, issued under G.O(P)No.16/2008/Tran. dated 7th April, 2008 and published as S.R.O No.370/2008 in the Kerala Gazette Extraordinary No.726 dated 8th April, 2008 is amended.

The notification is intended to achieve the above object.
