S.R.O. No. 490/93.—Whereas, representations have been received by the Government of Kerala from Private Bus Operators and from Kerala State Road Transport Corporation that the existing rates of concessional fare for students in the Stage Carriages should be revised;

And, Whereas, the Government of Kerala are convinced that, it is necessary to modify the directions issued to the State Transport Authority regarding concession to the students in the notifications G.O.(P) 27/88/PW&T dated the 23rd May, 1988 and published as S.R.O. No. 615/88 in the Kerala Gazette Extraordinary No. 444 dated the 23rd May, 1988 and G.O.(P) No.106/93/PW&T dated the 2nd November, 1990 published as S.R.O.No. 1477/90 in the Kerala Gazette Extraordinary No. 932 dated the 2nd November, 1990;

Now, therefore, in exercise of the powers conferred by clause (i) of sub-section (1) of section 67 of Motor Vehicles Act, 1988 (Central Act 59 of 1988) and in modification to the previous directions issued in this behalf, Government of Kerala hereby direct the State Transport Authority and the Regional Transport Authorities in the State as follows:—

DIRECTIONS

The State Transport Authority or the Regional Transport Authority as the case may be, shall fix the rate of concessional fare for students in the Stage Carriages as follows with effect from the first day of April, 1993:—

Student's Concession:—(1) Full time regular students not engaged in any other calling or profession studying in any recognised Educational Institutions travelling in stage carriages for a distance not exceeding 40 kms for a single journey for the purpose of attending classes shall be eligible for concession at the rate of 75% of the fare in force for the respective class of services for travel in city/Town and ordinary/Mofussil services. The amounts shall be rounded to the nearest multiple of 10 paise for each journey for the purpose of computation. For figures 1 to 5 at the end the lower multiple of ten and for 6 to 9 at the end the higher multiple of ten shall be adopted:

Provided that the minimum fare for a concession ticket for a single journey shall be 25 paise:

Provided further that the students shall produce identity cards in the form prescribed by the Government for claiming the concession.

(ii) Full time students not engaged in any other calling or profession studying privately in any institutions and who has registered his/her name in any of the Universities in Kerala as a student for a particular course of private study admitted by University travelling in stage carriages for a distance not exceeding 40 kms for a single journey for the purpose of attending classes shall be eligible for concession at the rate of 50% of the fare in force for the respective class of services for travel in city/Town and ordinary/Mofussil. services.

The amount shall be rounded to the nearest multiple of 10 paise for each journey for the purpose of computation. For the figures 1 to 5 at the end the lower multiple of 10 and for 6 to 9 at the end the higher multiple of 10 shall be adopted while calculating the fare:

Provided that the minimum fare for a concession ticket for a single journey shall be 40 paise:

Provided further that the students shall produce identity cards in the form prescribed by the Government for claiming the concession.

Explanation

"Recognised Educational Institutions" means

- Industrial Training Centres in the Public and Private sector affiliated to the National Council for Training in Vocational Trades.
- (ii) High Schools, Primary Schools and Special Schools and Training Schools and other recognised Educational Institutions under the control of the Department of Education;
- (iii) Colleges affiliated to the Universities;
- (iv) Technical Institutions recognised by the Director of Technical Education;
- (v) Educational Institutions recognised by Government of India; and
- (vi) Educational institutions directly run by the Government of Kerala or Government of India.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to lower the rates of concession for full time regular students and full time privately registered students in the stage carriages taking into account the hike in operational costs and the low concession rates fixed for the last so many years. This notification is intended to implement the Government decision in this regard.
