G. O. (P) No. 103 96 PW & T.

Dated, Thiruvananthapuram, 13th September, 1996.

S. R. O. No. 667 96.—Whereas representations have been received by the Government of Kerala that the students may be allowed to travel in Stage Carriages at the fare which existed prior to notification No. G. O. (P) No. 97 96 PW & T. dated 13th August, 1996;

And Whereas, the Government of Kerala are pleased to allow the request and it is necessary to amend the directions issued to the State Transport Authority by the said notification;

Now, therefore, in exercise of the powers conferred by Clause (i) of sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) the Government of Kerala hereby partially amend the notification issued under G. O. (P) No. 97 96 PW & T. dated the 13th of August, 1996 published as S. R. O. No. 613 96 in the Kerala Gazette Extraordinary No. 989 dated the 13th August, 1996, as follows:—

AMENDMENTS

In the direction issued in the said notification under the heading "G Student Concession" for items (i) and (ii) the following shall be substituted namely:

(i) Full time regular students not engaged in any other calling or profession studying in any recognised Educational Institutions for a recognised course travelling in Stage Carriage for a distance not exceeding 40 kilometres for a single journey for the purpose of attending classes, from residence to Institution shall be eligible for concession at the rate of 75% of the fare fixed in the notification issued under G. O. (P) No. 19|94| PW & T. dated the 28th March, 1994, for travelling in City|Town and Ordinary|Mofussil services.

The amounts shall be rounded off to the higher multiple of 10 paise for each journey for the purpose of computation:

Provided that the minimum fare for a concession ticket for a single journey shall be 25 paise:

Provided further that the students shall produce Identity Cards in the form prescribed by the Government as per G. O. (Rt.) No. 1324 90 PW & T. dated the 18th September, 1990 for claiming the concession:

Provided also that concession ticket will be issued for ten months in the academic year from the month of commencement of course.

studying privately in any Institutions and who has registered his her name in any of the Universities in Kerala as a student for a particular course or private study admitted by University travelling in Stage Carriages for a distance not exceeding 40 kilometres for a single journey for the purpose of attending classes from residence to Institution shall be eligible for concession at the rate of 50% of the fare fixed in the notification issued under G. O. (P) No. 19 |94 |PW & T. dated the 28th March, 1994 for travel in City|Town and Ordinary|Mofussil services.

The amount shall be rounded off to the higher multiple of 10 paise for each journey for the purpose of computation:

Provided that the minimum fare for a concession ticket for a single journey shall be 50 paise:

Provided further that the student shall produce Identity Cards in the form preceribed by the Government for claiming the concession:

Provided also that concession ticket will be issued for ten months in the academic year from the month of commencement of course.

This amendment will come into force with effect from the 16th of September, 1996.

Government have decided to reduce rates of concession fixed as per notification No. G. O. (P) 97-96 PW & T. dated the 13th August, 1996 published as S. R. O. No. 613 96 in Kerala Gazette Extraordinary No. 989 dated the 13th August, 1996 in the interest of the students. This notification is intended to achieve the above purpose.
