ORDER

Mass casual leave was availed by 263 executive staff of Motor Vehicles Department on 1.12.2009 in spite of specific instruction of Transport Commissioner contained in letter read as 2nd paper above. The unauthorized strike by a section of the executive staff has affected the prestigious "Road Safety Programme" of Government. The strike has seriously affected the functioning of the Department also.

On 19.6.10, 20 893 ministerial staff of Motor Vehicles Department went on strike after applying casual leave in protest against the implementation of "Fast Track Counter Service" in the RT Offices and Sub RT Offices.

Government have examined the matter in detail. As this type of unethical protest are recurring. Government have decided to take stern action. If such action is continued the goodwill of the Department will be lost among the public.

Hence Government order that the absence on duty of 263 executive staff on 1.12.2009 and the absence on duty of 893 ministerial staff on 19.6.2010 are treated as unauthorized absence and non duty. The salary of the absentees for the days mentioned above will be forfeited. Necessary entry will be made in the SB of the officers concerned.
