S. R. O. No. 370/2008.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) and in supersession of the special rules issued under G. O. (P) No. 164/PD dated 12th May, 1964 published in Part I of the Kerala Gazette No. 20 dated the 19th May, 1964, the Government of Kerala hereby make the following Special Rules for the Kerala Transport Subordinate Service, namely:—

Rules

- 1. Short title and commencement.—(1) These rules may be called the Kerala Transport Subordinate Service Rules, 2008.
- (2) The rules relating to physical qualifications specified in the Table under Rule 5 shall come into force at once and the remaining rules shall be deemed to have come into force on the 26th day of June, 1995.

- 2. Constitution.—The service shall consist of Assistant Motor Vehicle Inspectors.
- 3. Method of Appointment.—(1) Appointment to the service shall be made by direct recruitment or by transfer from among members of the ministerial service in the Motor Vehicles Department,
- (2) Appointment by transfer and by direct recruitment shall be made in the ratio 1:4.

Note:—In the absence of qualified hands for appointment by transfer, those vacancies shall be filled up by direct recruitment.

- 4. Appointing Authority.—The appointing authority shall be the Transport Commissioner.
- 5. Qualifications.—No person shall be eligible for appointment as Assistant Motor Vehicle Inspector by the method of appointment specified in column (1) in the table below unless he possesses the qualifications specified in the corresponding entry in column (2) thereof:—

Note:—The working experience shall be one acquired after having acquired the requsite educational qualification and the workshop from which such experience has been acquired shall be one registered with Government

4. Must hold a current valid diriving licence authorizing him to drive motor cycle, heavy goods vehicle and heavy passenger motor vehicle; and

Physical Qualifications

5. Must be physically fit and shall possess the following minimum physical standards:

(a) Height.—165 cms. for male candidates and 152 cms. for female candidates.

(b) Chest.—81 cms. with a minimum expansion of 5 cms. (applicable to male candidates only).

Note.—For candidates belonging to Scheduled Castes or Scheduled Tribes the minimum height shall be 160 cms. for male candidates and 150 cms. for female candidates.

(c) Visual Standards.—Must possess the visual standards specified below without glasses:

Note I:—(a) Each eye must have a full field of vision.

(b) Colour blindness, squint or any morbid condition of eye or lids of either eye shall be a disqualification for appointment.

- Note H: (The visual standards shall be certified by a Medical Officer not below the rank of an Assistant Surgeon specialized in Ophthalmology of a Government Hospital.)
- Note III:—Physically handicapped candidates shall not be eligible for applying to the post.
- 1. Pass in SSLC or its equivalent
- 2. (i) A diploma in Automobile Engineering or Mechanical Engineering awarded by the State Board of Technical Education (3, year course). or
 - (ii) Any qualification in either of the above disciplines declared as equivalent to the above diploma by the Central Government or the State Government
- 3. Working experience of at least one year in a reputed automobile workshop which undertakes repairs of both light motor vehicles, heavy goods vehicles and heavy passenger motor vehicles fitted with petrol and diesel engine
- Note I:—The working experience shall be one acquired after having acquired the requisite educational qualification and the workshop from which such experience has been acquired shall be one registered with Government.
- Note II:— In the case of persons appointed by transfer and in service prior to the date of publication of this notification, the condition regarding working experience provided in Note I need not be insisted.
- 4. Must hold a current valid driving licence authorising him to drive motor cycle, heavy
 goods vehicle and heavy passenger motor vehicle

Physical Qualifications

- 5. Must be physically fit and should possess the following minimum physical standards:
 - (a) Height.—165 cms. for male candidates and 152 cms. for female candidates
 - (b) Chest.—81 cms.. with a minimum expansion of 5 cms. (applicable to male candidates only)
- Note:—For candidates belonging to Scheduled Castes or Scheduled Tribes the minimum height shall be 160 cms. for male candidates and 150 cms. for female candidates.
 - (c) Visual standards:— Must possess the visual standards specified below without glassess:

Right eye Left eye

- Note I.—(a) Each eye must have full field of vision.
 - (b) Colour blindness, squint or morbid condition of eye or lids of either eye shall be a disqualification for appointment.
- Note II:—The visual standards shall be certified by a Medical Officer not below the rank of an Assistant Surgeon specialized in Ophthalmology of a Government Hospital.
- Note III:—Physically handicapped candidates shall not be eligible for transfer to the post.

- 6. Pass in Account Test (Lower) and Departmental Tests on the laws relating to Motor Vehicles administered by the Motor Vehicles Department; and
- 7. Three years experience in the ministerial subordinate service of the Motor Vehicles Department.
- 6. Qualification regarding age:—No person shall be eligible for appointment as Assistant Motor Vehicle Inspector by direct recruitment, if he has not completed the age of 21 years or has completed the age of 43 years as on the first day of January of the year in which applications for appointment are invited and for appointment by transfer, if he has not completed the age of 21 years on the date of such appointment.
- 7. Reservation of appointment:—The rules relating to reservation of appointment specified in rules 14 to 17 in the Kerala State and Subordinate Service rules, 1958, shall apply to appointments by direct recruitment.
- 8. Probation:—Every person appointed to the service shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
- 9. Tests:—Every person appointed by direct recruitment shall within the period of probation, pass the Account Test (Lower) if he has not already passed the test and the Departmental Tests on the laws relating to Motor Vehicles administered by the Motor Vehicles Department.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government of India, as per Notification S.O. 443 (E) dated the 12th June, 1989 published in Gazette of India Extraordinary Part II, Section 3(11) dated the 12th June, 1989 as amended by S.O. 301 (E) dated the 29th April, 1991, have prescribed the minimum qualification for the class of officers consisting of the category of Inspector of Motor Vehicle and Assistant Inspector of Motor Vehicles. Government have decided to fix the minimum qualifications prescribed by the Central Government in the Special Rules for the Kerala Transport Subordinate Service also. It is also decided to include certain physical specifications for the persons seeking appointment to the post of Assistant Motor Vehicles Inspector. Since the Special Rules issued in G.O. (P) No. 164/PD dated the 12th May,1964 qualification specified above, it is decided to revise the rules in supersession of the existing rules on the subject.

This notification is intended to achieve the above object.

S. R. O. No. 820/2018.—In exercise of the powers conferred by subjection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 168), the Government of Kerala hereby make the following rules to amend the Kerala Transport Subordinate Service Rules, 2008 issued under G. O. (P) 16, 16/2008/han, dated 7th April, 2008 and published as S. R. O. No. 370/2008 in the Marsia Gazette Extraordinary No. 726 dated 8th April, 2008, markely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Transport Subordinate Service (Amendment) Rules, 2018.
 - (2) They shall come into force at once.
- 2. Amendment of the Rules.—In the Kerala Transport Subordinate Service Rules, 2008,—
- (1) in the TABLE under rule 5, against the entry, "1. By direct recruitment" in column (1),—
- (i) in item 2 in column (2), after sub-item (i) and the entries against it the word "or" shall be inserted,
- (ii) in the Note under item 3 in column (2), for the word "requsite", the word "requisite" shall be substituted;
- (iii) in item 4 in column (2), for the word "diriving", the word "driving" shall be substituted,
- (2) for the rule 6, the following rule shall be substituted, namely:—

 "6. Qualification regarding age:—
 - (i) For appointment by Direct Recruitment
- No person shall be eligible for appointment as Assistant Motor Vehicle Inspector by direct recruitment, if he has not completed 21 years of age and has completed 36 years of age as on the first day of January of the year in which applications for appointment are invited, with relaxations applicable to Scheduled Castes, Scheduled Tribes and Other Backward Classes as per the existing rules.

For appointment by transfer

No person shall be eligible for appointment as Assistant Motor Vehicle Inspector by transfer, if he has not completed 21 years of age on the date of appointment".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Kerala Transport Subordinate Service Rules, 2008, issued under G. O. (P) No. 16/2008/Tran, dated 7th April, 2008 and published as S. R. O. No. 370/2008 in the Kerala Gazette Extraordinary No. 726 dated 8th April, 2008, certain errors have crept in, which have to be rectified. The Subordinate Legislation Committee (2014-2016) in its 23rd report has recommended to insert the word "or" in between items (i) and (ii) in the Table under Rule 5 in the entries in column (2) against 'By direct recruitment' in column (1); re-fix the maximum age limit for the post of Assistant Motor Vehicles Inspector by direct recruitment as 36 years and also to incorporate provision for relaxation of age allowed to Scheduled Castes and Scheduled Tribes and Other Backward Classes. The Government have decided to rectify the errors and incorporate the above changes in the said rules.

The notification is intended to achieve the above object.
