Subject: Proof documents for issuance of driving license and registration certificate.

Madam/Sir,

The Motor Vehicles (MV) Act, 1988 and Central Motor Vehicles Rules (CMVR), 1989 governs the issuance of driving license and registration certificate across the country.

- 2. Rule 4 of CMVR, 1989 provides for documents which can be submitted as proof of correctness of address and age for obtaining Driving License.
- 3. Further, rule 47 pertains to the application for registration of motor vehicles wherein the proof of address shall be one of the documents referred to in rule 4. Additionally, proof of identity of nominee is to be submitted in case nominee is mentioned.
- 4. As a facilitative measure to citizens, this Ministry is developing a proposal to expand the set of documents which be submitted as Proof of Identity (POI), Proof of Address (POA) and Proof of Age/Date of Birth for issue of driving license and registration certificate. In this regard, reference has been taken from the list of acceptable documents for updation of Aadhaar issued by UIDAI.
- 5. Therefore, the proposed list of acceptable documents for Proof of Identity, Proof of Address and Proof of Age/ DOB in case of driving license and registration certificate is appended as Annexure 1.
- 6. It is requested to please provide your observations and suggestions on the proposal by 10th May, 2023 at comments-morth@gov.in.
