### AMENDMENT

In the said notification, -

- (i) for the words "who have registered with the Travancore – Cochin Medical Council", the words "who have registered with the Kerala State Medical Council" shall be substituted;
- (ii) after the words "or its equivalent" the words "or the B.A.M.S Degree" shall be inserted;
- (iii) the last sentence shall be omitted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G.O(P)No.70/89/PW&T. Dated 30<sup>th</sup> June, 1989 and published as S.R.O.No.1146/1989 in the Kerala Gazette Extraordinary No.616 dated 30<sup>th</sup> June, 1989, the Government have appointed all Medical practitioners in Kerala who have registered with the Travancore – Cochin Medical Council and who possess the M.B.B.S. Degree or its equivalent to be the authority for issuing the Medical Certificate in Form 1A for the purpose of sub-section (3) of section 8 of the Motor vehicles Act, 1988. Now, the Government have decided to appoint Ayurveda Medical Practitioners in Kerala who possess B.A.M.S degree also for issuing the Medical Certificate for the purpose of sub-section (3) of section 8 of the Motor Vehicles Act, 1988 by amending the said notification.

The notification is intended to achieve the above object.
