S.R.O. No..... /2018.- WHEREAS the draft rules further to amend the Kerala Motor Vehicles Rules, 1989 were issued as required by sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) as per notification No.70/B2/2018/Trans dated 30<sup>th</sup> April, 2018 and published in the Kerala Gazette Extra Ordinary No.1240 dated 08<sup>th</sup> May, 2018, inviting objections or suggestions on the draft rules from the persons likely to be affected thereby;

AND WHEREAS, no objection or suggestion has been received on the said draft rules;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) and clause (a) of sub-section(2) of section 28 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) , the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Rules, 1989, namely:-

RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Motor Vehicles (Second Amendment) Rules, 2018.  
(2) They shall come into force at once.
2. *Amendment to the Rules.*- In the Kerala Motor Vehicles Rules,1989, in rule 4, after paragraph 4, the following sentence shall be inserted as a separate paragraph, namely:-

"The Assistant Motor Vehicle Inspectors shall be the Junior Licensing Authority solely for the purpose of issue of "fresh learner's licence".

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport)

As per rule 4 of Kerala Motor Vehicles Rules, 1989, the Regional Transport Officer, Joint Regional Transport Officer and Motor Vehicle Inspector are the Licensing Authority, Additional Licensing Authority and Assistant Licensing Authority respectively in respect of that region. In order to facilitate the implementation of 'SARATHI 4,' the Transport Commissioner had requested the Government to authorise Assistant Motor Vehicle Inspectors as Junior Licensing Authority only for the purpose of issue of Fresh Learners licence. Hence the Government have decided to amend the said rule to authorise Assistant Motor Vehicle Inspectors as Junior Licensing Authority solely for the purpose of issue of fresh learner's licence.

The notification is intended to achieve the above object.
