S.R.O.No....../2014:- WHEREAS, in pursuance of the powers conferred by clause (iii) of the proviso to sub – rule (1) of rule 108 and sub – rules (2), (3) and (4) of the said rule of the Central Motor Vehicles Rules, 1989, the Government of Kerala, vide notification issued under G.O.(P) No. 28/2014/Trans. dated the 19<sup>th</sup> March, 2014 and published as S.R.O. No. 209/2014 in the Kerala Gazette Extraordinary No. 918 dated the 20<sup>th</sup> March, 2014, have permitted the vehicles carrying high dignitaries specified therein to use red, blue or multi coloured lights;

AND WHEREAS, the Government have decided to specify more high dignitaries to be included in Schedule III of the said notification permitting them to use blue light with flasher while on duty anywhere in the State;

NOW, THEREFORE, in pursuance of the powers conferred under clause (iii) of the proviso to sub – rule (1) of rule 108 and sub rules (2), (3) and (4) of the said rule of the Central Motor Vehicles Rules, 1989, the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No. 28/2014/Tran dated 19<sup>th</sup> March, 2014 and published as S.R.O. No. 209/2014 in the Kerala Gazette Extraordinary No. 918 dated the 20<sup>th</sup> March, 2014, namely:-

## AMENDMENT

In Schedule III of the said notification, after serial no. 9, the following serial numbers and entries shall be inserted, namely:-

- "10. The Vice Chancellors of the various universities in the State of Kerala.
- 11. Officers of and above the rank of Additional Principal Chief Conservator of Forests of the Indian Forest Service ".

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport)

Rule 108 of the Central Motor Vehicles Rules, 1989 empowers the State Government to specify the high dignitaries for the purpose of the rule and to specify the motor vehicles carrying such high dignitaries on which red, blue and multi coloured lights shall be fitted. Government have issued a notification under the said rule and published it as S.R.O. No. 209/2014 in the Kerala Gazette Extraordinary No. 918 dated the 20<sup>th</sup> March, 2014 and subsequently amended the notification vide S.R.O. No. 361/14 published in the Kerala Gazette Extraordinary No. 1538 dated 18<sup>th</sup> June, 2014. Now, the Government have decided to include the Vice Chancellors of various universities in the State of Kerala and Officers of and above the rank of Additional Principal Chief Conservator of Forests of the Indian Forest Service in the list of high dignitaries mentioned in Schedule III of the notification.

The notification is intended to achieve the above object.
