Vide reference 3rd cited, the Automotive Research Association of India has extended the validity of the earlier Test Report No. SHL/223/2014-2015/71/1123 dated 08-04-2016 has extended the Speed Limitation Device installed on the vehicle model "SARTAJ 3335W/O CARGO BOX XM BSIII" to the vehicle model "SARTAJ 5252 XM with Cargo Box" BS III and its variants mentioned in the Annexure. Vide reference 4th cited, the Automotive Research Association of India has extended the Test Report No.SHL/223/2014-2015/71/1123 issued to SARTAJ 3335 W/O CARGO BOX XM BSIII to SARTAJ 3335

All the Registering Authorities and Additional Registering Authorities are directed to verify the above while registering the vehicles subject to the compliance of Central Motor Vehicles Rules, 1989 as amended up-to-dated. They are also directed to verify the compliance of provisions of Act and Rules other than those mentioned in the ARAI Certificate.

The applicant is directed to produce the copy of ARAI test report for each vehicle at the time of inspection of vehicle fitted with these speed governors. You are also requested to make sure the speed limiter which is in built in the vehicle is working properly.


