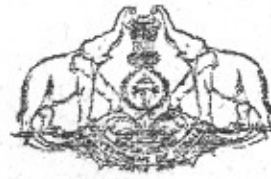

- Sub:- Re-introduction of HBA to Government Employees and Teachers - Time extension - revised instructions -reg
Ref:- 1. G.O (P)No.505/09/Fin dated 12.11.09
2. Letter No. FB (A) 11-50585/09 dated 15.12.09 from the Commissioner, Land Revenue.

In the Government Order 1st cited, it is ordered that all Head of the Departments should forward the details of the eligible applications in the prescribed form as stipulated in Appendix III of the Government Order before 31.12.09 to Finance Department in the current Financial Year. As per the letter 2nd cited, the Land Revenue Commissioner has requested to extend the time limit for submission of the details of application to Government. He has also requested to authorize the District Collectors also to scrutinize recommend and forward the eligibility list of HBA in Appendix III, working under them to Finance Department since this system was prevailed in the old House Building Advance Scheme.

2. Government have examined the matter and are pleased to extend time limit for forwarding the eligible applications from 31.12.2009 to 30.01.2010 and to authorize District Collectors to scrutinize, recommend and forward the eligibility list of House Building Advance of the employees of Revenue Department working under them to Finance Department.
