

Dear Paakash,

As per Section 10 of the Kerala Road Safety Act 2007, one time Cess has to be collected from all Motor Vehicles used or kept for use in this state. Rule 6 of Kerala Road Safety Authority Rules 2007, provides for collection of Cess. In the Budget 2008 – 2009 Government have allotted a new head of account namely <u>0041 – 00 – 800 – 99(01) Receipts</u> under Kerala Road Safety Authority 2007 for remitting the Cess collected under the Kerala Road Safety Act. Prior to the opening of this new head of account, the amount of Cess collected was credited to the head of account <u>0041 – 00 – 800 – 99 other receipts.</u>

As per sub section (3) of Section 11 of Kerala Road Safety Authority Act 2007, Government shall contribute to the Kerala Road Safety Fund every year, an amount equal to fifty percent of the compounding fee collected in the previous year under section 200 of the Motor Vehicles Act, 1988. But no separate head of account for crediting the proceeds under Compounding fee was opened till September 2008. As per GO (Rt) No. 7341/08/Fin dated 05.09.2008 a separate head of account <u>0041 - 00 - 97 - 102</u> was opened for accounting receipts collected under Compounding fee. Till then Compounding fee collected by the Motor Vehicles Department was credited under the head of account <u>0041 - 00 - 101 - 99</u>.

Government have informed that transfer of funds to Kerala Road Safety Authority shall be with reference to reconciled figures under the provisions of Kerala Road Safety Authority Act, and requested to make available the actual figures of receipt under the provisions of Kerala Road Safety Authority Act duly reconciled with the figures of Treasuries and the Accountant General. In spite of repeated instructions to furnish the reconciliation statements, you have not yet done it in the required manner. Government contribution to the Kerala Road Safety Fund is pending from the year 2008 - 2009 onwards due to non receipt of reconciled figures. This has

resulted in acute shortage of funds to the Authority, at a time when the Authority is implementing various projects and programmes as part of road safety activities.

In these circumstances you are once again requested to bestow your personal attention in the matter and arrange to furnish the reconciled figures including that of the sub offices under your jurisdiction, in the following format within 2 days. Any further slackness in the matter will be viewed seriously.
