Decision: The State Transport Authority, in its's Meeting held on 04.01.2018, decided to implement certain changes in the existing 'D3 Circular' with a new set of timings. Consequent to this, the Managing Director, Kerala State Road Transport Corporation has filed representation before the Secretary to Government and also filed objection before the Chairman, STA pointing out the adverse effect

of the revised timings i.e., the time settled to the LSOS in the double lane is lesser than that of the Super Class vehicles owned by the State Transport Undertaking.

Considering the urgency in the matter, the subject matter was circulated among the Chairman and Members of STA under Rule 130 of Kerala Motor Vehicles Rules and invoking the inherent powers of the STA under Section 68 of Motor vehicles Act, the decision taken on 04.01.2018 in the Departmental Item No.1 was kept in abeyance until further orders and also decided to review the decision in the next meeting.

Heard the objections and suggestions of the representatives of the Managing Director, Kerala State Road Transport Corporation and various Private Bus Operator's Associations and discussed the matter in detail.

On a scrutiny of the existing and revised timings, the objection filed by the State Transport Undertaking is found genuine.

As the Government notification in G.O.(P).No.73/2013/Trans dated 16.07.2013 in SRO.No. 555/13, the right to operate any class of service other than ordinary service in the State of Kerala and to increase the trips is reserved exclusively with State Transport Undertaking and taking into consideration the request of Kerala State Road Transport Corporation, it is hereby decided to retain the running time for any class of service other than ordinary service of State Transport Undertaking as it prevailed before

04.01.2018. Hence the decision of STA dated 04.01.2018 shall be implemented w.e.f. 21.04.2018 with modified timings as follows:-
