ORDER

As per the letters read as 1st paper above, the Transport Commissioner proposed to introduce e-payment facility in Motor Vehicles Department and requested to accord formal sanction for implementing the same with State Bank of India and State Bank of Travancore.

Government have examined the proposal in detail and are pleased to accord Administrative sanction for introduction of e-payment facility for fee/tax collection for various services in Motor Vehicles Department subject to the following guidelines.

The District Treasury, Thiruvananthapuram is designated as the Treasury for e-banking facility. The Treasury Branch, Thiruvananthapuram of the State Bank of Travancore will act as the link branch of the Agency Bank. All online payment transactions made up to 8 pm should be transferred to the Reserve Bank account on the next day before 11 am by the link Branch of the Agency Bank of the Treasury.

The link Branch (the Treasury branch of the State Bank of Travancore) shall provide the scroll containing the individual details of the collection. The link Branch Manager shall also give an authenticated printed copy of the scroll and a soft copy of the same in the prescribed format to the Treasury on a daily basis.

The State Bank of Travancore / State Bank of India shall also give an MIS report on the collection to the Motor Vehicles Department daily.

The Treasury shall update the data in TIS and generate a sequence number and gives the soft copy of the scroll with Treasury with the Treasury sequence number and the date to Motor Vehicles Department for updation in KVATIS on a daily basis.

The specimen format of the receipt proposed to be issued while accepting money through e-payment mode should be prepared by the Transport Commissioner as per the requirements of the Motor Vehicles Department.
