**S.R.O. No. /2010.-** In exercise of the powers conferred by clause (vii) of sub section (2) of section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Rules, 1989, the same having been previously published as per Notification No. 7227/B2/05/Tran. dated the 18<sup>th</sup> May, 2010 in the Kerala Gazette Extraordinary No. 1196 dated the 24<sup>th</sup> May, 2010, as required by sub-section(1) of section 212 of the said Act, namely:-

**RULES**

1. Short title and commencement. - (1) These Rules may be called the Kerala Motor Vehicles (Amendment) Rules, 2010.

(2) They shall come into force on and from the first day of October, 2010.

2. Amendment of the Rules.- In the Kerala Motor Vehicles Rules, 1989, in rule 164, for items (d) and (e) and the entries against them the following items and entries shall, respectively be, substituted, namely:-

(d) Stage Carriage	Rs. 5000	-
(i) Temporary Permit under clauses (a) and (b) of sub section (1) of section 87 of the Act.	-	250
(ii) Temporary Permit under clause (c) of sub section (1) of section 87 of the Act	-	500
(e) Special permit under sub section (8) of section 88 of the Act		
(i) for Stage Carriage	-	500
(ii) for other types of Public Service Vehicles	-	250

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Stage Carriages are issued with temporary permit under item (c) of sub-section(1) of section 87 and special permit under sub-section (8) of section 88 of the Motor Vehicles Act, 1988 for operating as contract carriages in connection with marriages, rallies etc. Government have decided to enhance the fee for temporary permit and special permit and make it equal to that for contract carriages and to avoid revenue loss in this behalf.


The notification is intended to achieve the above object.
