## ORDER No. C1/3136/TC/2016 DATED 25-05-2016

Vide reference 1<sup>st</sup> cited, Motor Vehicles Department decided to install Speed Limiting Devices in all Transport Vehicles plying in Kerala and action was taken to empanel the Manufacturers, who confirms the standards fix by the Department and invited applications from the manufacturers.

As per the invitation 10 Firms submitted their Speed Limiting Devices and connected records to the Department. Transport Commissioner constituted an empanelment committee chaired by Assistant Transport Commissioner and the Committee met on 06-05-2016 and verified the document submitted by the Firms and submitted the report. Based on the report an Apex Committee constituted under the chairmanship of the Joint Transport Commissioner & Sec. STA with 4 members.

The apex committee meeting was held on 24-05-2016 at Transport Commissionerate and evaluated the documents submitted by the participating manufacturers as per the general conditions prescribed by the Motor Vehicles Department.

Based on the evaluation, the following firms are empanelled by the Transport Commissioner for the supply and service of speed control devices through out Kerala.

They are:

- 3. M/s Digila Devices Pvt. Ltd
- 4. M/s Pricol
- 5. M/s Rosemerta Auto Tech Pvt. Ltd.

Empanelment of the following two firms will be done on production of the documents mentioned against their names.

1	M/s Micro Auto Tech	-	Registration Certificate under the Companies Act 1956 & registration with Commercial Taxes Department.
2	M/s Thinture Technologies Pvt. Ltd	-	Registration details with commercial Taxes Department

The performance of these firms will be scrutinized by the Transport Commissioner periodically and if any deficiency of Stock of device or any discrepancy in service is noticed, the empanelment will be revoked without any notice. Fresh firms will be empanelled if they are found suitable for empanelment. Regional/Joint Regional Transport Officers are free to inspect the dealership/service centers at any time without any notice.
