SRO No./2016.- In exercise of the powers conferred by section 28 of the Kerala Motor Vehicles Taxation Act, 1976 (Act 19 of 1976), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Taxation Rules, 1975, namely:-

RULES

 Short title and commencement.-(1) These rules may be called the Kerala Motor Vehicles Taxation (Amendment) Rules, 2016 (2) They shall come in to force on the 1st day of January, 2017

2. Amendment of the Rules. - In the Kerala Motor Vehicles Taxation Rules, 1975,-

(a) in rule 4,the existing rule shall be numbered as sub-rule(1) of that rule and after sub-rule(1) as so numbered, the following subrule shall be inserted, namely:-

" (2) The Green Tax levied under section 3A in respect of every non transport vehicle shall be paid in cash at any Regional Transport Office or Sub Regional Transport Office or Motor Vehicles Checkposts or by e-payment and the Green Tax levied in respect of every transport vehicle shall be paid in cash to the office where the vehicle is last registered or by e-payment:

Provided that the Green Tax in respect of vehicles registered in other State and plying in the State of Kerala shall be paid in cash at any checkpost of the Motor Vehicles Department";

(b) in rule 7, the existing rule shall be numbered as sub-rule(1) of that rule and after sub-rule(1) as so numbered, the following sub-rule shall be inserted, namely:-

"(2)The tax licence for the remittance of Green Tax shall be in Form 'GTL':

Provided that where there is a facility for e-payment of Green Tax, the receipt obtained shall be the Green Tax licence and the same shall be in Form 'EGTL' ";

- (c) for rule 9, the following rule shall be substituted, namely:-
- "9. Production of Tax Licence.- The valid Tax Licences shall be carried in the vehicle and shall be produced on demand by an officer authorised by Government as per section 11 or a police officer not below the rank of Sub Inspector";

(d) in rule 10, for sub- rule (1), the following sub-rule shall be substituted, namely:-

"(1) The previous intimation referred to in sub-section(1) of section 5 shall be made to the Regional Transport Officer or Joint Regional Transport Officer concerned in FORM G and accompanied with a receipt of remittance of appropriate fee as specified in the table below, so as to reach him within thirty days before the commencement of the period for which exemption from payment of tax in respect of the vehicle is claimed due to non-use:-

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

As per rule 10 of the Kerala Motor Vehicles Taxation Rules,1975, an application for non-use intimation shall be reached before the Regional Transport Officer within seven days from the date of commencement of the period of tax exemption claimed. But, this provision is found mis-used by certain vehicle owners by using the vehicle for the first 7 days of the quarter and the G form was filed on the seventh or eighth day claiming tax exemption from the beginning of this quarter. In order to curb the mis-use of G form, it is decided to make amendment in rule 10 of the said Rules that the application for tax exemption shall be filed within 30

days before the commencement of the quarter and certain fee is introduced for filing G form and also decided to revise the existing "FORM G".

As per section 3A of the Kerala Motor Vehicles Taxation Act, 1976, Government have introduced 'Green Tax' for old motor vehicles, for the implementation of various measures to control air pollution. The payment of tax levied and form of Green Tax Licence are to be prescribed.

The fee for the grant of duplicate tax licence is now just ₹5/-.The Government have decided to revise the fees as ₹100/-.

This notification is intended to achieve the above objects.
