Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(Ms) No. 11/2018/Trans. dated 9th February, 2018, Government of Kerala have sanctioned six new Sub Regional Transport Offices consequent to the formation of 12 new Taluks including Kattakkada, vide G.O. (P) No. 283/2013/RD. Dated 27th June, 2013.
