S.R.O.No-----/2018.- In exercise of the powers conferred by notification dated 12th June, 1989 of the Government of India, Ministry of Surface Transport issued under sub section (6) of section 41 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), published as S.O.No.444 (E) in the Gazette of India dated 12th June, 1989 in Part II, section 3, sub-section (ii), the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P) No. 68/89/PW&T dated 30th June 1989 published as S.R.O. No. 1148/89 in the Kerala Gazette Extraordinary No.619 dated the 1st July 1989, namely:-

Explanatory Note.

(This does not form part of the notification, but is intended to indicate its general purport.)


As per notifications issued under G.O.(P) No.68/89/PW&T dated 30th June 1989 published as S.R.O.No. 1148/89 in the Kerala Gazette Extraordinary No.619 dated the 1st July, 1989. Government have allotted code numbers to the Registering Authorities of different regions to be used in registration mark assigned to the vehicles registered in the regions concerned. By amending S.R.O. 1148/89 as per notifications issued under G.O.(P) No. 20/02/Tran. dated 31st August, 2002, published as S.R.O. No. 689/2002 in the Kerala Gazette Extraordinary No. 1300 dated 3rd September, 2002 and G.O. (P) No. 29/06/Tran. dated 15th May, 2006 published as S.R.O. No. 413/2006 in the Kerala Gazette Extraordinary No. 964 dated 5th June, 2006 and G.O(P) No. 23/2011/Tran. dated 29th March, 2011 Published as S.R.O. No. 246/2011 in the Kerala Gazette Extraordinary No. 801 dated 30th March, 2011 and GO(P) No.01/2013/Tran. dated 15th January, 2013 published as S.R.O. No. 59/2013 in the Kerala Gazette Extraordinary No. 227 dated 28th January, 2013. Government have allotted Separate code numbers to Regional Transport Offices and all the Sub Regional Transport Offices in the state with a view to have administrative convenience and transparency in the allotment of registration numbers to Motor Vehicles.

As per G.O(Ms) No.11/2018/Tran. dated 9th February, 2018, Government have accorded Sanction for the establishment of new Sub Regional Transport Offices at Kattakada, Thriprayar, Nanmanda, Perambra, Iritty and Vellarikundu. Therefore, it has become necessary to allot separate code numbers to the Additional Registering Authorities of the above said regions to be used as registration mark.

This notification is intended to achieve the above object.
