ORDER

- In order to improve the efficiency of the administrative machinery and to enable the speedy disposal of official business, the State Government consider that the existing financial powers of various departments need suitable revision/enhancement at each hierarchial level in time with the present day requirement of each department.
- Accordingly, the Empowered Committee on Revision of Delegation of Financial Powers convened on 12.08.08 have recommended to enhance the delegation of Financial Powers of Additional Transport Commissioner/Joint Transport Commissioner, Senior Deputy Transport Commissioner/Deputy Transport Commissioner, Regional Transport Officer/Joint Regional Transport Officer and officers of equivalent rank of Motor Vehicles Department as detailed below.
