S.R.O. No..... /2018.- WHEREAS, the draft rules further to amend the Kerala Motor Vehicles Rules, 1989 were issued as required by sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) as per notification No.179/B2/2018/Tran. dated 29th June, 2018 and published in the Kerala Gazette Extra Ordinary No.1843 dated 10th July, 2018, inviting objections or suggestions on the draft rules from the persons likely to be affected thereby;

AND WHEREAS, no objection or suggestion has been received on the said draft rules;

NOW, THEREFORE, in exercise of the powers conferred by clause (xviii) of sub-section (2) of section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Rules, 1989, namely:-

RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Motor Vehicles (Third Amendment) Rules, 2018.

(2) It shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Motor Vehicles Rules, 1989, in rule 295, in clause (a),-

(i) after first proviso, the following proviso shall be inserted, namely:-

“Provided further that the autorickshaws using CNG/LNG as fuel shall be painted in golden yellow colour for the hood part and eco green colour for rest of the part”;

(ii) in the existing second proviso, for the words "Provided that", the words "Provided also that" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)


As per rule 295 of the Kerala Motor Vehicle Rules, 1989, colour code for CNG & LNG have not been determined. Government received many representations from vehicle manufacturers in this regard. Government have examined the matter in detail and decided to amend rule 295 of the Kerala Motor Vehicle Rules, 1989, so that the autorickshaws driven using CNG/LNG fuels shall be painted in Golden Yellow for hood part and Eco Green for rest of the part, for a separate identity.

This notification is intended to achieve the above object.
