 - (a) New vehicle models of category L2 with;
 - (i) engine capacity ≤ 125 cc;
 - (ii) maximum continuous rated or net power ≤ 11kw; and
 - (iii) power/weight ratio ≤ 0.1 kw/kg,

manufactured on and after the 1st April, 2018 shall be fitted with anti-lock braking system or combined braking system conforming to IS: 14664: 2010;

- (b) Existing vehicle models of category L2 with:
 - (i) engine capacity ≤ 125 cc;
 - (ii) maximum continuous rated or net power ≤ 11kw; and
 - (iii) power/weight ratio ≤ 0.1 kw/kg,

manufactured on and after the 1st April, 2019 shall be fitted with anti-lock braking system or combined braking system conforming to IS: 14664: 2010:

Provided that all other category of two wheeled vehicles which does not fall in the criteria as mentioned above in clause (a) and (b) shall be fitted with anti-lock braking system conforming to IS: 14664: 2010 on and after the 1st April, 2018 for new vehicle models and on and after the 1st April, 2019 for existing vehicle models."
