S.R.O. No./2017. WHEREAS, the Government had approved a Scheme in public interest for the purpose of providing an efficient, adequate, economical and properly co-ordinated passenger road transport service in relation to 31 routes all over Kerala as per Notification issued under GO(P) No.42/2009/Tran. dated.14th July,2009 and published as SRO No.608/2009 in the Kerala Gazette Extraordinary No.1272 dated 14th July,2009;

WHEREAS, the Government of Kerala having the opinion that the above said notification requires modification;

AND WHEREAS the proposal regarding the modification Scheme for the purpose was published as draft Scheme to modify the said Scheme, as per Notification No.12878/B1/2015/Tran. dated. 8th February, 2016 in the Kerala Gazette Extraordinary No.359 dated.11th February, 2016 and in the Deshabhimani daily dated 15th February,2016 and Kerala Kaumudi daily dated 15th February,2016 as required by Sub-section (2) of section 102 of the Motor Vehicles Act,1988(Central Act 59 of 1988) read with Clause (b) of rule 246 of the Kerala Motor vehicles Rule,1989;

AND WHEREAS, the State Government, after having considered the objections received against the draft Scheme and after having heard the objectors and representatives of State Transport Undertaking, are satisfied that it is necessary in public interest to implement the Scheme relating to the proposal with modifications;

NOW THEREFORE, in exercise of the powers conferred by sub-section (1) of section 102 of the Motor Vehicles Act,1988(Central Act 59 of 1988) read with clause (d) of rule 246 of Kerala Motor vehicles Rules,1989, the Government of Kerala hereby approve the proposal regarding the modified Scheme as stated below that the passenger road transport service as per the particulars in the Schedule given below should be run and operated exclusively by the State Transport Undertaking.

The permits granted in the Private Sector as on 14 th July, 2009 will be permitted to operate as Ordinary or Ordinary Limited Stop Service. The maximum distance prescribed in the rule 2(oa) in the Kerala Motor Vehicle Rules, 1989 shall apply to these saved permits provided that further extension or variation shall not be allowed under any circumstance. This Scheme shall not affect the operation of other State Transport Undertakings.

apply for permits to replace the existing Stage Carriages as above shall be taken by the Chief Executive of the State Transport Undertaking.

- 5 If the operation shall be to the exclusion of other services:--
- a) Whether such exclusion shall be complete or partial: Partial till the existing private services operating on the routes are replaced as provided in item 4 above Partial.
- b) If such exclusion shall be partial, the sectors of the route from where other services are to be excluded; and: The existing services issued with permit on or before 9th May, 2006 and after 9th May, 2006 shall be permitted to continue as in clause 4 above till they are replaced by buses owned by the State Transport Undertakings. The existing and operating permits as on 14th July, 2009 will be permitted to operate as Ordinary or Ordinary Limited Stop Service.
- c) Whether it is proposed to allow other services to pick up or set down passengers between any two places on the route covered by the Scheme: Yes, on the portion of the route permitted to operate as in clause 4 above. Permits will also be granted to private stage carriages of other routes permitting them to overlap 5 kilometre or 5 percent of the length of their own routes, whichever is less on the notified routes, for purposes of intersection. Yes, existing and operating permits in the Private Sector as on 14th July, 2009 are allowed to operate subject to modified clauses 4 and 5(b). Permits will also be granted to private stage carriages on other routes permitting them to overlap 5 kilometre or 5% of the length of their own routes, whichever is less on the notified routes, for the purpose of intersection.
- 6 The maximum and minimum number of vehicles to be operated in relation to each area or route by the State Transport Undertaking: As per traffic demand No modification
- 7 The maximum and minimum number of trips to be provided in relation to each route or area by the State Transport Undertaking in the case of stage carriages: As per traffic demand No modification

Explanatory Note

(This does not form part of the notification, but it is intended to indicate its general purport)

As per notification issued as GO(P) No. 42/2009/Tran. dated.14th July, 2009 and published as SRO No. 608/2009 in the Kerala Gazette Extraordinary No.1272 dated 14th July, 2009, Government of Kerala issued a schedule for providing an efficient,adequate,economical and properly co-ordinated passenger road transport service in the 31 routes all over Kerala.

Thereafter, the Government of Kerala decided to modify the said Scheme and issued a preliminary notification as No.12878/B1/2015/Tran. dated 8th July 2016 and published in the Kerala Gazette Extraordinary No.359 dated 11th February, 2016 . In clause 4 of the said notification, it was proposed that the permits granted and issued in the private sector as on 14th July,2009 will be permitted to operate as Ordinary or Limited Stop Ordinary Service. It was also proposed that the maximum distance prescribed in rule 2 (oa) in the Kerala Motor Vehicles Rules,1989 shall not be applicable to these permits. But subsequently clause (oa) of rule 2 of the said rules have been amended so as to limit the route length.

As per section 102 of the Motor Vehicles Act,1988 the State Government have the power to modify any approved Scheme after issuing a preliminary notification for the purpose.

Therefore after considering the objections and hearing the objectors and the representatives of the State Transport Undertaking, the Government have now decided to finalise and publish the modified Scheme with the modification that the permits granted and issued to Private Sector as on 14th July, 2009 will be permitted to operate as Ordinary or Ordinary Limited Stop Service subject to a route length having a distance not exceeding 140 kilo meters.

The notification is intended to achieve the above object.
