SRO No. /2010. In exercise of the powers conferred by sub Section (1) of section 200 of the Motor Vehicles Act. 1988 (Central Act 59 of 1988) and in supersession of the notification No.G.O.(P) No.9/2002, dated 20<sup>th</sup> March 2002 published as SRO No.157/2002 in the Kerala Gazette Extra ordinary No.303 dated 22<sup>nd</sup> March 2002, the Government of Kerala hereby authorize all officers of and above the rank of Assistant Motor Vehicles Inspectors of Motor Vehicles Department and all officers of and above the rank of Sub Inspectors of the traffic branch of the Police Department and where there is no traffic branch, all officers of local police of the area of and above the rank of Circle Inspector of Police to compound the offences punishable under various provisions of the said Act specified in column (2) of the schedule below for the amounts specified in column (3) thereof.
