ORDER

As per Government Order first read above, all Motor Vehicles belonging to the Government of Kerala are to be given third party Insurance coverage and that the Insurance can be with United India Insurance Company.

2. As per the letter read above, Director of Insurance has reported that the Kerala State Insurance Department is now issuing third party insurance coverage for the vehicles of State Public Sector Undertakings, Boards, Corporations etc. as well as those financed by the State Government or other State Government agencies. Eventhough the Department is insuring all kinds of vehicles under the above categories, vehicles belonging to the State Government are insured with the United India Insurance Company Ltd. The Kerala State Insurance Department is the appropriate agency to insure State Government Vehicles. The Department has Development Officers in all Districts who could provide assistance to the concerned Departmental Officers in getting their vehicles insured. The insurance of the vehicles can be arranged through the District Insurance Office concerned.

3. After having examined all aspects in the matter in detail, Government are pleased to order that all Motor Vehicles belonging to the Government of Kerala be given third party insurance coverage and that the insurance henceforth will be with Kerala State Insurance Department.

4. The expenditure on Insurance Premium will be debited to the head of account— "Office Expenses" in respect of the Departments concerned.

5. Orders on the modalities of Insurance will be issued separately.
