WHEREAS, the Government are satisfied that the operation of contract carriages specified in Serial No.1 and stage carriages specified in item (ii) of Serial No.2 under rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975 have been affected due to the



outbreak of COVID 19 pandemic and the operators of such vehicles are facing acute financial crisis;

AND WHEREAS the Government, in exercise of the powers conferred by the proviso to rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, have extended the period of remittance of quarterly tax for the quarter commencing from the 1st day of April, 2021 in respect of contract carriages and stage carriages ordinarily kept in the State up to the 31st day of May, 2021 as per notification issued under G.O. (P)No.14/2021/Trans dated 7th May, 2021 and published as S.R.O No.390/2021 in the Kerala Gazette Extraordinary No.1563 dated 10th May, 2021;

AND WHEREAS, as it is necessary in the public interest, so to do, the Government have now decided to further extend the period of remittance of tax for the period commencing from 1st day of April, 2021 and 1st day of July, 2021 in respect of contract carriages and stage carriages ordinarily kept in the State up to the 31st day of August, 2021;

NOW, THEREFORE, in exercise of the powers conferred by the proviso to rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975 the Government of Kerala, in public interest, so to do, hereby extend the period of remittance of tax for the period commencing from the 1st day of April, 2021 and 1st day of July, 2021 in respect of contract carriages and stage carriages ordinarily kept in the State up to the 31st day of August, 2021.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

For the reasons stated in the notification, the Government have decided to further extend the period of remittance of tax prescribed in rule 5 of the Kerala Motor Vehicles

Taxation Rules, 1975, permitting the operators of stage carriages and contract carriages including Autorickshaw and Taxi, ordinarily kept in the State to remit the motor vehicles tax due from the quarters commencing from the 1st day of April, 2021 and 1st day of July, 2021 up to the 31st day of August, 2021.

The notification is intended to achieve the above object
