ORDER

As per Government Orders read as 1st and 2nd papers above, M/s IDTR Kerala Hazardous Institute, Kandanakam, Edappal, Malappuram and Safe and Secure Institute, Udayamperoor, Ernakulam have been granted permission to conduct training to drivers of vehicles transporting hazardous and dangerous goods. Later government issued guidelines for according sanction to such institutes as per Government Order read as 3rd paper above.

The Transport Commissioner has forwarded applications of M/s IDTR Kerala Hazardous Institute, Kandanakam, Edappal, Malappuram and Safe and Secure Institute, Udayamperoor, Ernakulam to renew their licenses as per letters read as 5th and 6th papers above, in accordance with the provisions of Government order read as 3rd paper above. The Transport commissioner has reported that both the institutes are equipped with all the requisite facilities including experienced trainers for imparting training to the drivers of vehicles carrying hazardous goods.

Government have examined the matter in detail and are pleased to grant permission to renew the licenses of M/s IDTR Kerala Hazardous Institute, Kandanakam, Edappal, Malappuram and M/s Safe and Secure Institute, Udayamperoor, Ernakulam for imparting training to the drivers of vehicles carrying hazardous goods, in accordance with Rule 9 (1) of CMVR, 1989, the provisions and guidelines issued as per Government Order read as 3rd paper

above and standing instructions in this regard from time to time.

4. The Motor Vehicle Department officials shall conduct a proper enquiry and ensure the compliance of all legal requirements for the purpose before the issuance of permit.
