Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government of Kerala as per G.O.(Ms) No.13/2019/Trans. dated 11th February,2019, have accorded sanction to establish seven new Sub-Regional Transport Offices where there were no Sub-regional Transport offices. The new Sub-Regional Transport Office, Payyannur is situated in Kannur region. Therefore, Government have decided to notify the area comprising Payyannur Sub-region in Kannur region and the area of jurisdiction of the Joint Regional Transport Officer of the said Sub-region and also to redefine the areas comprising Kannur region and Thalassery, Thaliparambu and Iritty Sub-regions and to notify the area of jurisdiction of the Joint Regional Transport Officers, concerned, by superseding all the existing notifications with respect to Kannur region and also the notification issued under G.O.(P) No.8/2019/Tran. dated 19th February,2019 and published as S.R.O.No.162/2019 in the Kerala Gazette Extraordinary No.521 dated 27th February,2019, with respect to Iritty, Thalassery and Thaliparambu Sub-regions.

The notification is intended to achieve the above object.
