

As per the reference 1st cited, copy of Accountant General's letter requesting to submit pension papers of all the employees of the department, who are due to retire on 31.03.2010 was forwarded to you for compliance and necessary action. Regarding.

Ref: - (1) Circular No. 43/09/Fin, dated 11.5.2009.
(2) D.O. Letter No.PM/2/1435/09-10/462 dated 25.1.2010 from the
Deputy Accountant General (P).

In the Circular cited 1st, all Heads of Departments were instructed to forward pension papers sufficiently early to the Accountant General (A&E) well before 30th September every year, in order to avoid inordinate delay in sanctioning pensionary claim.

The Accountant General (A&E), Kerala in his letter cited 2nd has brought to the notice of the Government that out of 19000 pension cases, during the current financial year 8000 pension papers are yet to be received, which causes inconvenience to the Accountant General to sanction a huge number of pension cases at a time.

All Heads of Departments are therefore requested to submit pension papers urgently to the Accountant General (A&E). Accountant General/Government shall not be responsible for the belated payment of pensionary benefits in cases of delayed submission of pension papers and consequent loss if any.
