I am to invite your attention to the reference cited and to inform that, with regard to the PAC meeting held on 16.01.2013, the Committee has sought for additional details regarding:

- i) the amount collected so far,
- ii) the Action taken to collect the balance amount
- iii) the amount outstanding collection
- iv) non collectable amount and the reason thereof,
- v) whether there was any lapse in initiating the RR steps both in the Motor Vehicles Department and District Collectorates,

With regard to the action in Para 5.3.1 of the above report, the Committe has sought for the Government decision regarding the matter that the Driving Licence for NTV and TV are being renewed simultaneously. Hence I am to request you to furnish necessary proposal to Government for taking a decision in the matter.

With regard to the action in Para 5.3.6 of the above report, the Committe has recommended for taking stringent action and to explore the possibility of detention of the overloaded vehicles, so that fine could be levied without delay.

A consolidated reply stating the amount under each item in the concerned Paras of the above report has to be furnished, as recommended by the PAC. The Committee has also recommended for taking disciplinary action against those officers who failed to initiate RR proceedings.

In view of the above recommendations given in the meeting of the PAC held on 16.01.2013, I am to request you to take immediate necessary follow up action and to furnish details to Government without any delay.

Form no. 6 is the form of driving lisence. The deserription of rehieles liverneed to drive is hoped in the form. Some of the vehicles are tereneport and others use non transport. Hence the validity of T.V. (for 3 years) and NTV (20 yrs) are provided seperately on the form. But the both volodifies are attested by single signature. There is no valuality for the badge as mentioned is the audit para. There is validity for the likence only which is authorise to drive T.V or NTV or both. In the ease of licence to drive a motor ear (Lmv) the valuatity is for 20 yrs. After one year he can obtain a badge so that he is authorised to drive a taxi which is T.V. Then the volidity to drive T. V. is to be filled up. (for 3 years). When the validaty to draine T.V. exprires but the validity to draine NTV 18 valud (eg: for 6 months) he has to games apply for sunewal again after 6 months. It is public harrowsment, There is no seperate fees preserrated for the renewal of T. Vand NTV. Hence it is advisable to Genew NTV (5 yrs) also while renewing T.V (for 3 yrs.) otherwise numerous problems will wrise.
