The existing Ink cartridge of the Postal Franking Machine in the Transport Commissionerate Despatch section , AITT Despatch Section, RTO Vatakara, RTO Thrissur and RTO Pathanamthitta, has been used up completely. As per the paper read as 1st above this office has given sanction to all RTOs and Sub RTOs to purchase ink catridge locally. As per paper read as 2nd above Transport Commissionerate Thiruvananthapuram, purchased one ink catridge for their Franking Machine from M/s Divya Business Systems Pvt Ltd. Accordingly the firm had supplied one ink catridge and produced their Bill vide paper read as 3rd above for a total amount of Rs 3044/- (Rupees Three Thousand and Forty four only)

Hence sanction is accorded for disbursing an amount of Rs 15220/- (Rupees Fifteen thousand two hundred and twenty only) (3044 X 5 = 15220/-) to M/s Divya Business Systems Pvt Ltd towards the cost of item supplied.
