Transport Department -Establishment of Motor Vehicles Department – Opening of Eight New Sub Regional Transport Offices-Creation of additional posts-Sanctioned -Orders Issued.

ORDER

The Estimates Committee (2001-2004) in its 9th report had recommended for the opening of New Sub Regional Transport Offices in 10 Taluks where no Sub Regional Transport Offices were sanctioned. As per the Government Order read as 1st paper above sanction was accorded for starting new Sub Regional Transport Offices in Kunnathur, Ranni, Thirurangadi Taluks and also at Angamaly and Chalakkudy. Now the Taluks of Udumbanchola, Nilambur, Devikulam, Mananthavadi, Sulthanbathery, Kuttanadu, and Chittur do not have a Sub Regional Transport Office.

The Transport Commissioner vide letters read as 2nd paper above has proposed to open new Sub Regional Transport Offices in the aforesaid Taluks and one at Uzhavoor. The Transport Commissioner has reported that vehicle population has been increased in Uzhavoor, where there was a Sub Regional Transport Office which was shifted to Vaikom. For opening each Sub Regional Transport Office the Transport Commissioner has proposed to create 18 posts of

various categories which requires the creation of 144 posts altogether for eight Sub Regional Transport Offices as indicated below:

As the functioning of the above eight new Sub Regional Transport Offices are found essential for the revenue collection, strengthening of enforcement mechanism and rendering improved service to the public sanction is accorded for opening eight Sub Regional Transport Offices in seven Taluks viz Udumbanchola, Nilambur, Devikulam, Mananthavadi, Sulthanbathery, Kuttanadu, and Chittur and at Uzhavoor and for the creation of the above 144 additional posts.


