WHEREAS, the proviso to clause (iii) of sub-section (1) of section 93 of Motor Vehicles Act, 1988 (Central Act 59 of 1988), provides that while issuing the licence to an aggregator, the State Government may follow such guidelines as may be issued by the Central Government;

AND WHEREAS, the Ministry of Road Transport and Highways in pursuance to



section 93 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) have issued the Motor Vehicles Aggregator Guidelines, 2020, vide notification under S.O. 4251(E) dated 26th November, 2020;

AND WHEREAS, paragraph 18 of the said guidelines provides that an aggregator, aggrieved by any order passed by the Competent Authority may, within 30 days of receipt of the order, appeal to the State Government or such other agency as may be notified by the State Government;

NOW, THEREFORE, in exercise of the powers conferred under paragraph 18 of the Motor Vehicles Aggregator Guidelines, 2020, the Government of Kerala hereby notify that the Secretary to Government, Transport Department is to be the Appellate Authority before whom an appeal under the provisions of the State Motor Vehicles Aggregator Policy, may be filed.

WHEREAS, as per clause (iii) of sub-section (1) of section 93 of the Motor Vehicles Act, 1988, (Central Act 59 of 1988) no person shall engage himself as an aggregator unless he has obtained a licence from competent authority;

AND WHEREAS, the proviso to clause (iii) of sub-section (1) of section 93 of Motor Vehicles Act, 1988 provides that while issuing the Licence to an aggregator, the State



Government may follow such guidelines as may be issued by the Central Government;

AND WHEREAS, the Ministry of Road Transport and Highways in pursuance to section 93 of the Motor Vehicles Act, 1988 have issued the Motor Vehicles Aggregator Guidelines, 2020, vide notification under S.O. 4251(E) dated 26th November 2020;

AND WHEREAS, as per the Motor Vehicles Aggregator Guidelines, 2020, "Competent Authority" means the State Government or any other authority empowered by the State Government to issue Licence under section 93 of the Act;

NOW, THEREFORE, in exercise of the powers conferred under clause (iii) of subsection (1) of section 93 of the Motor Vehicles Act, 1988, the Government of Kerala hereby empower the Transport Commissioner to be the Competent Authority to issue licence to an aggregator subject to the provisions of the State Motor Vehicles Aggregator Policy.
