ORDER

In the G.O read as 1 st paper above Government have fixed the monetary limits to the powers of the Assistant Executive Engineers of Mechanical Sub Division/Regional Engineering workshops in respect of issue of Essentiality Certificates for the repair and replacement of parts of Government Vehicles. As per the GO read as 2 nd paper above, Government have enhanced the powers of the Assistant Executive Engineer and Executive Engineer of the Mechanical wing to issue the certificate. Now as per the letter read as 3 rd paper above the Chief Engineer, Mechanical, Irrigation Department has requested to enhance the monetary limit to the powers of Executive Engineers and Assistant Executive Engineer, Mechanical Sub Division, Public Works Department in respect of Essentiality Certificate for the repairs and replacement of parts of Government vehicles.

2. Government have examined the matter in detail and are pleased to enhance the powers of Assistant Executive Engineer and Executive Engineer of the Mechanical wing, PWD to issue Certificates and delegation of powers of Chief Engineer (Mechanical) for according

Administrative Sanction for Repairs to vehicle as follows.

The of Assistant powers Executive Engineers of Mechanical Sub Divisions for issuing the *Essentiality* Economy Certificate is revised from **Rs.25,000/**to **Rs.** 40,000/for **Light** Medium Vehicles and from Rs.40,000/- to Rs.60,000/for Heavy Vehicles..
