
As per order read as 1st above, 34 Enforcement Squads have been created in the Motor Vehicles Department. As per order read as 2nd above, the above Enforcement Squads were attached to all the Regional Transport Offices; except the Regional Transport Office (NS), Thiruvananthapuram.

As per order read as 5th above, 51 Enforcement Squads have been created in addition to the above-mentioned 34 Squads. In the said order, it has been directed that the newly formed 51 Enforcement Squads and the existing 34 Enforcement Squads shall work under 14 Regional Transport Offices (Enforcement). For the smooth functioning of the Enforcement Wing, it is necessary to shift the posts of 34 MVIs which are attached to the Regional Transport Offices. In the circumstances, the posts of 34 Motor Vehicles Inspectors are shifted to Regional Transport Offices (Enforcement) in the following manner:
