ORDER

As per the letter read above, Transport Commissioner has requested to accord administrative sanction for the purchase of 284 numbers of Smart Phones at an estimated cost of Rs.71 lakh (Rupees Seventy One Lakh only/-) under the scheme 'Implementation of e-Governance' in the financial year 2023-24 for enforcement activities in Motor Vehicles Department. The technical committee constituted for the purpose has approved the technical specifications required and recommended to procure and provide smart phones to all enforcement officers and accordingly the Transport Commissioner has submitted the proposal as per the letter read above.

- 2.The Departmental Working Group meeting held on 27.12.2023 approved the above proposal for purchase of 284 Smart Phones under the scheme 'Implementation of e-Governance-Purchase of ICT equipment' for an amount of Rs.71 lakh (Rupees Seventy One Lakh only) in the financial year 2023-24 under the Head of Account "5055-00-800-90 (PV)", subject to certain conditions.

Government have examined the matter in detail and are pleased to accord administrative sanction for purchase of 284 Smart Phones at an estimated cost of Rs.71 lakh (Rupees Seventy One Lakh only/-) under the scheme 'Implementation of e-Governance' in the financial year 2023-24 under the Head of Account "5055-00- 800-90 (PV)", subject to the following conditions

- 1) Tender to be invited at the GeM portal following the Store Purchase Rules/Government Orders in force.
- 2) The possibility to get extended warranty/AMC for 5 years, inclusive of warranty period shall be explored.
