In exercise of the powers conferred on me under proviso to rule 4 of the Kerala Motor Vehicles Rules, 1989, it is hereby notified as follows:

The Regional Transport Officer (Nationalised Sector) and the Motor Vehicles Inspector (Nationalised Sector) shall also be the Licensing Authority and Assistant Licensing Authority, Trivandrum respectively within the jurisdiction of the following Villages of the Corporation of Trivandrum, namely:-

- (a) Kudappanakunnu
- (b) Peroorkkada
- (c) Vattiyoorkavu

The Notification shall come into force at once.

Explanatory Note

(This does not form the part of the above notification, but is intended to indicate its general

Number of applications being received in Regional Transport Office, Thiruvananthapuram for driving licences and learner's licence is huge, which is increasing day by day. Now this has reached beyond the control limits of that Office. Huge increase in the number of applications is also creating difficulties to the public. Increasing the capacity of CALLS at Regional Transport Office, Thiruvananthapuram is not feasible since present infrastructure available in that office is very limited. Hence it has been decided to start CALLS at Regional Transport Office (Nationalised Sector), Kudappanakunnu.

As per the proviso to Rule 4 of the Kerala Motor Vehicles Rules, 1989, the Regional Transport Officer (Nationalised Sector) and the Motor Vehicles Inspector (Nationalised Sector) shall also be the Licensing Authority and Assistant Licensing Authority, Trivandurm respectively within the jurisdiction as may be specified by the Transport Commissioner, from time to time by notification in the Official Gazette.

The notification is intended to achieve the above object.
