Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(P) No. 11/2018/Trans. dated 9th February, 2018, Government of Kerala have sanctioned six new sub regional transport offices consequent to the formation of 12 new Taluks including Iritty vide G.O.(P) No. 283/2013/RD. dated 27th June, 2013. Therefore Government have decided to define the areas of jurisdiction of the newly created Sub Regional Transport Office, Iritty and redefine the area of jurisdiction of Sub Regional Transport Offices of Thalassery, Thalipparambu and Regional Office of Kannur.

The notification is intended to achieve the above object.
