Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(P) No. 11/2018/Trans. dated 9th February, 2018, Government of Kerala have sanctioned six new sub regional transport offices consequent to the formation of 12 new Taluks including Thamarassery in Kozhikode district vide G.O.(P) No. 283/2013/RD. Dated 27th June, 2013. Therefore Government have decided to define the areas of jurisdiction of the newly created Sub Regional Transport Office, Nanminda and Sub Regional Transport Office Perambra and redefine the areas of jurisdiction of Sub Regional Transport Offices of Koyilandy and Koduvally and Regional Transport Offices of Kozhikode and Vada kara.

The notification is intended to achieve the above object.
