Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(Ms)No.11/2018/Trans. dated 9th February, 2018, Government of Kerala have sanctioned six new sub regional transport offices consequent to the formation of 12 new Taluks including Chalakkudy in Thrissur revenue district vide G.O.(P) No. 283/2013/RD. dated 27th June, 2013. Therefore Government have decided to define the area of jurisdiction of the newly created Sub Regional Transport Office, Thriprayar and redefine the areas of jurisdiction of Sub Regional Transport Office of Guruvayoor and Regional Transport Office, Thrissur.
