Based on the directions of the Hon'ble Supreme Court appointed Committee on Road Safety with an objective to reduce the number of road crashes and to ensure the safety of the road users, the Department has launched a special drive "Operation Suraksha" under the personal supervision of the Joint Transport Commissioner (Enforcement).

The Honorable Supreme Court Committee on Road Safety have instructed the disqualification of Driving Licences for a minimum period of three months under Section 19 of the MV Act, 1988 read with Rule 21 of CMV Rules, 1989 for:

- (i) Driving at a speed exceeding the specified limit including red light jumping.
- (ii) Carrying overload in goods carriages and carrying persons in goods carriages
- (iii) Driving vehicle under the influence of drink and drugs
- (iv) Using mobile phone while driving a vehicle

In this connection, Standard Operating Procedures regarding the detection of above said offences and follow up actions are already issued from this office and all Regional Transport Officers were directed to sent a weekly compliance report (by Friday) to this office without fail. It is regretted to note that this direction is not being adhered to. Further more, discrepancies are noticed in the figures being furnished. As such you are requested to furnish the details of total licence suspensions in the proforma attached for Q.E. 30.06.2017. Also, the monthly data shall be furnished in the said proforma to this office on the 1st working day of every month along with the revenue collection statement without fail. All Deputy Transport Commissioners shall ensure that the statements being furnished by the officers under their jurisdiction are accurate and should furnish a quarterly consolidated statement.
